

Trask Ranch Speech

July 13, 2024

I'm offering tonight a sober time of reflection, an honest assessment of the world around us, and for us to look into the mirror and call for a time of repentance, like the faithful prophet Daniel on behalf of God's people of Israel, said in Chapter 9 – "We have sinned." A guy like me is invited to speak here tonight due to the broad range of knowledge of the Christian religion, ranching, economics, social order and family life that is the man, Pat Trask. What a range of speakers he has brought in over the years. I last spoke here in 2011 and I was brutal on public education. Some were offended, many more now see what I saw back then,

My high-school sweetheart and I have been married for nearly 49 years and we are the parents of 11 children. We have 38 grandchildren so far. I used to own half of a community bank in NW Iowa. I sold it in 1985 and then did due diligence exams of banks from Rapid City, east through Iowa, Minnesota and Nebraska for investors wanting to purchase free-standing community banks or failed ones that were recapitalized by the FDIC. Some of the biggest bankers in those states offered me senior management positions at the age of 30. I turned them down as I began to understand the curse God places on a nation whose money system is built on unjust weights and measures. At a banking conference in the early 1980s I heard your then Governor Bill Janklow tell the story of how Citibank decided to move to South Dakota; and also the state's new outrageously high usury law the legislature had passed. My fellow bankers were giddy. My heart ached thinking about how the middle class, nationwide, would suffer paying such unbiblical rates. This further helped me realize I was no longer fit for the industry.

What did Janklow's loosening of the usury laws help create besides usurious suffering for the middle class and poor? Consider that the FDIC Bank Call Reports of March 31, 2024, showed total deposits of all South Dakota banks being the highest amount of any state in America at \$2.8 T. New York state was second at \$1.4 T and Texas was third. These South Dakota deposits help fund a total of \$3.5T in South Dakota bank assets, with New York second at \$1.7 Trillion.

As PBS reported a couple of years ago South Dakota has become a global haven for private trusts. These trust balance sheets are now included with your local banks. The South Dakota Division of Banking, charged with regulating them, currently lists 118 such trusts licensed to operate in your state. The website of one of the first trusts chartered in the state, **South Dakota Trust Company**, says they administer \$140 billion in trust assets, and they currently work with over 118 billionaires and 410 centimillionaire clients.

Al W. King is Co-chair of the South Dakota Trust Company. His office is at 10 E 40th Street, NYC. He is six blocks from the Empire State Building, 10 blocks from Rockefeller Center and about 30 minutes up Long Island from the Federal Reserve Bank of New York. Craig Kennedy, former state Senator from Yankton, told PPS that the trust industry in South Dakota has basically captured the state legislature and can essentially pass whatever they put together."

These trusts have become effective competitors to international banks in Switzerland and Panama in providing almost complete secrecy of the assets and their owners to those who turn the administration of their assets over to them. While most of you get your lives turned over to the regulatory, taxing and financial proctologists for an uncomfortable examination of everything you have and everywhere you spend your money, the global billionaires are parking their money right here in your state and get unimaginable secrecy provided by South Dakota state law. PBS cited a South Dakota lawyer stating that this was an offshoot of Janklow's efforts with Citibank.

Who owns these trust assets and what influence they have on your state government is unknowable. Again, why can't the native-born South Dakotans enjoy the same immunity from government intrusions that the global elite are afforded by South Dakota law?

After I got out of the bank consulting business the Holy Spirit began directing my thoughts on how God's Law applies to economics and our entire social order. I began studying the impact of unjust money on middle class families and the demographic depopulation of societies that tolerate them. By the late 1980s and early 1990s I also began studying the impact of feminism, contraception in marriage, Christ-less education and psychotherapy (which I came to know as psychoheresy) and concluded that the Western World founded on Christianity was in trouble.

Those I place the greatest blame on, are the churches that decided God's Law was no longer relevant. We lost our 'plumb line' as the Bible calls it and opened ourselves to a Satanic worldview. I asked my wife Debra, who had previously walked away from her national award-winning journalism career, to join with me to sacrifice our once profitable banking life for a life of service to Christ, the church and our communities. I warned her there would be blowback and there was, but Christ became our strength and our guide ever more.

I was called to the pro-life fight and after spending a weekend in the Fulton County, GA prison farm for peacefully blocking the doors to a downtown Atlanta abortion clinic I came home to launch the rescue movement in Sioux Falls. We were popular at first, having many pastors, priests and even the late Bishop Paul Dudley of the SF Diocese join us blocking doors and getting arrested. There is a Christian diesel mechanic in Sioux Falls that my wife and I held in our arms when he was six weeks old. His mother was scheduled to kill him but changed her mind after seeing us being arrested by S.F. police. I have spent time in seven jails in five states, for peacefully trying to stop the murder of babies.

But soon I saw the enemy was not Planned Parenthood as much as it was....us.

Consider, you have a Constitutional Amendment G up for a vote this fall to overturn your state trigger law (which banned abortion after Roe was overturned) if this passes it would thus legalize abortion in your state. The grassroots Christians must fight continuously, putting in hours a week calling friends, family, etc. to get them to vote no. Yet, I fear something. I fear it will pass.

The **Argus's** early June polling shows it leading by an 18% margin. It only had a 2% lead in November. Not surprising to me the poll found 46% of registered Republicans were in favor of legalizing abortion again in South Dakota. How did we get here?

If it does pass, I believe it will serve as God's judgment against us Christians and the state's prolife leadership. We've compromised for decades and have led the majority population to this very point. First, let us look at the big picture. Elon Musk, father of twelve children (though I don't recommend his way of doing it) is now tracking diaper sales for old people vs. those for babies...in the Western world. He reports the rate of diaper sales for old people a couple of years ago passed the baby-diaper rate. He told Tucker Carlson in April of 2023,

"That once you have birth control and abortions you can still satisfy the limbic instinct but not procreate. "We haven't yet evolved to deal with that. That is fairly new you know...the last 50 years or so for birth control. I'm sort of worried that if we don't make enough people to at least sustain our numbers a little bit, then civilization is going to crumble."

Tucker Carlson himself is telling young people the way to resist the growing tyranny is for a young man to get a job above his skill-set, get married young and have lots of babies. These men are saying what the establish-ment pro-life movement has not said from the beginning. Afterall, it was Catholic Bishop James T. McHugh of New Jersey who served as the guiding force in the late 1960s to establish National Right to Life Committee; and at the same time was serving with a Dr. Mary Calderone, the then-medical director of PPFA, to help establish SIECUS the Sex Information and Education Council of the U.S. Their goal in the late 60s was to sexualize the American public, via their schools and churches. They succeeded. Later, when former PPFA president Alan Guttmacher was asked, "What makes abortion so secure in America, he replied, "That's easy, Sex Ed."

So now let's look at South Dakota numbers. About the time of Roe v. Wade there were nearly 17 births per 1,000 population. 20 years before that, before contraception, it was at 27 births pre 1,000 population. It is now near 13 births per 1,000, half the rate from nearly 70 years ago. The death rate during that time rose from 7 per 1,000 in 1975 to 12 in 2022. (14 rate x assume avg. population 600 (1,000s) x 70 years = 588,000 people)

Don't you think it's time to consider that the establishment pro-life movement **has had other goals** over these years than to oppose the sexual revolution's contamination of children for the last two generations, or goals other than promoting marriage/motherhood, goals other than to oppose feminism, and not to raise a high standard against the marriage-crushing family court system? No, they haven't effectively opposed any of this. Have they warned young couples to live frugally and stay away from the damned bankers and online credit, encourage Christian families to have as many babies as God would give them? What were their goals because they failed at all of this? **Again, we are demographically dying.**

When do we study God's Law and **we** repent and change our ways to conform to God's Law?

So what's the current pro-life movement in S.D. going to do about Constitutional Amendment G? I suspect they'll do what they've been doing since I walked away from

the Sioux Falls battles in the early 1990s...make lots of noise, compromise a bit more, concede the Hegelian dialectic further to the pagans, make the fight about themselves and possibly pocket some cash along the way.

\$120,000 of the \$209,000 raised by Life Defense Fund (PAC) (that's 57%) as of the end of last year has been spent on Consulting. Who are these consultants and what services are they providing?

Let me suggest something, if you are inclined to donate to them...ask them for a breakdown of the consultant's names and how much each has received. If the consultant is an anonymous LLC, make them require their corporate registered agent to provide you with a list of the individuals that own this LLC...before you donate them a dime. Even then if the consultants list "media buys" ask for media invoices and find out if that's "net" cost or were their commissions added in.

In the early 1990s I publicly opposed a rape, incest and life of the mother exceptions bill in the South Dakota legislature. It dominated the media but was defeated by a single vote in the Senate. But sandwiched on either side of that vote was KELO TV's annual poll on abortion. They asked the same questions, to the same sample size, in the same demographic distribution in the same week of those two years. This legislation had the horrible impact I thought it would have on the public. There was a 4.0% (+or-) reduction in the number of SD citizens who thought **all abortions** should be banned and those who thought some abortions should be allowed (those who didn't want to be "so extreme") grew by 3%. We lost ground among the public because of pro-life compromise. Do this over decades and what do you get? Charles Rice, of Notre Dame law school later published a study on the harm of pro-life exceptions-based legislation, and cited my South Dakota report.

Meanwhile, get your churches to join with other churches and your church leaders to publicly repent of our many compromises and then work with humble hearts to oppose Amendment G. But if it's all 'media buys,' we'll continue to be seen as 'clanging cymbals' as the Bible says. But if it's humility and toil for the glory of Christ, God may intervene to stop this 30-year pattern of compromise. And if we don't repent and change, I suspect the pro-aborts will be right back even it's defeated. They know we don't have the spiritual/moral threshold that we had two generations ago. And adding doctor-attending regulations to the chemical abortions (mifepristone and misoprostol) in South Dakota still concedes the point that chemical abortions are permitted.

But in the end, as your state demographics show, these 'culturally losing' 'money harvesting' pro-life groups have gone on for decades helping yield your internal state population decline. And certainly, the Boomers retiring into your state are NOT going to stop this.

We've lost by increments for so many years we find ourselves fighting bestiality taught in schools and the transgender movement, something most would never have thought possible ten years ago. Well, most, but not the Sioux Falls mayor Paul TenHaken. For five years in a row the mayor signed a **public proclamation honoring the achievements of transgenders**. He ignored my seven letters to him, and to his pastor, to his Minnesota church he grew up in, and to his parents in the Spring of 2023 asking him to repent and to stop it. That is, until some Christian men joined me, and we started picketing his church, Shalom Christian Reformed Church, and Sioux Falls Christian

High School where his kids attend. Since we started in early June of 2023, the mayor has stopped signing it, but has never **publicly** repented.

Did you know **there is** a dominant religion today that teaches there are more than two genders? It is not the Muslims and obviously not Christians. It is Talmudism, that is Talmudic Judaism.

If you thought nonbinary gender was a modern concept? Think again. As Rachel Shinerman wrote at **MyJewishLearning.com** "The ancient Jewish understanding of gender was far more **nuanced** than many assume. The Talmud, a huge and **authoritative** compendium of Jewish legal traditions, contains in fact no less than eight gender designations. She lists male and female and then six more. One includes *Aylonit adam*, an identified female at birth but later developing male characteristics through human intervention. <https://bit.ly/TalmudGenders>

In 1964 Elizabeth Kilpatrick Dilling of Chicago wrote the book, **The Jewish Religion: Its Influence Today**. Dilling (who for some time at been underwritten by Henry Ford), wrote that, "Bible scholars are aware that Jesus Christ denounced the Pharisees. Christ said they nullified all the Commandments of God by their Tradition, teaching for doctrines the commandments of men (Mark 7:13; Matt. 15:6-9, etc.). His invective cannot be equaled. All of Matthew 23 is like a whiplash. He likened Pharisaism to a whited sepulcher, indeed beautiful outwardly, but "inside full of dead men's bones and of all uncleanness." Christ climaxed one condemnation after another with the expletive, "Hypocrites!" He called the Pharisees children of them that killed the Prophets. He foretold they would go on killing, crucifying and persecuting until the guilt for all the righteous blood shed from Abel on down would be upon them. "Ye serpents, ye generation of vipers, how can ye escape the damnation of hell?" Christ asked.

Although Christ admitted in John 8 that His hearers were descendants of Abraham, He knew they wanted to kill Him. He said they were spiritually, of the devil. (John 8:44).

"But," says the disinterested Christian, "what has that to do with us today? What a group of Pharisees did two thousand years ago is over and done with!" However, the missing link in Christian understanding about the subject of "Pharisees" is best supplied by the Universal Jewish Encyclopedia (1943), which says, The Jewish religion as it is today traces its descent, without a break, through all the centuries, from the Pharisees. Their leading ideas and methods found expression in a literature of enormous extent, of which a very great deal is still in existence. The Talmud is the largest and most important single piece of that literature ... and the study of it is essential for any real understanding of Pharisaism."

Yet **Karaite (Care-ite)** Jewish Rabbis are a stark contrast to the Talmudic/Zionists. They adhere to the Pentateuch only (Torah). No less important is that the **Karaite** Jews condemn the oral traditions now placed into print, the Talmud. Their condemnation written 1,000 years ago by Karaite Rabbi Salmon ben Yeruham, says,

"The Holy One has given you an oral Law, So that you would recite it orally. For, say you, He had deemed it, in His wisdom, a laudable command. Why, then, did you **write it down** in ornate script? Had the Merciful One **wished** to write it down, He would have had it written down **by Moses**. Now did He not give it to you to be studied orally, And had He **not** ordained it not to be inscribed in a

book? Yet they altered God's alleged words and wrote it down, And instead of studying it orally they transferred it into writing. How, then, can their words be believed, seeing that they have offended grievously?"

The Talmudists consider these Karaite Jews the worst "antisemites." I know of no reason why a Karaite Jew would not be a good neighbor, seeing they believe in the OT Law. BTW, the Karaite synagogue in Jerusalem is the oldest synagogue in the Old City – Jewish Quarter of the city.

With Governor Kristi Noem's recent signature to HB 1076, the updates to the definition of discrimination which your state's Human Rights Commission can sanction people, now include 'antisemitism.' The state code defers to the International Holocaust Remembrance Alliance of Berlin for the statute's definition of antisemitism to include the **perception** of certain speech as hatred toward Talmudists. A mere perception?! Your free speech is being directly challenged by this new South Dakota law.

As I wrote to your governor, the Talmud says, Jesus was a bastard conceived when an evil spirit slept with Mary. Mary was a prostitute and committed adultery. Jesus committed bestiality. Jesus is in hell where his punishment is "boiling in hot semen."

The city of St. Louis, MO was named after King Louis the 9th of France who oversaw the Paris Disputation, also known as the Trial of the Talmud, in the year 1240 between a wise Catholic Bishop versus four leading rabbis. The Talmud's great blasphemies against Christ were exposed and in 1242 King Louis 9th of France decreed the burning of all copies of the Talmud. Again, the city of St. Louis was later named after this King, who made this decree.

For two millennium many in the early church, Roman Catholics and Protestant leaders publicly condemned the Talmud; and the rabbis who taught its blasphemies. But as E. Michael Jones says in his book, **Jewish Revolutionary Spirit** "Once Christians lost the will to contest it, judaizing was a natural consequence; the rise of the Talmud in Christian culture was a function of that loss of will. The inordinate craving for the magic which Cabala dangled before the eyes of credulous Christians became the chief impediment to contesting the Talmud." Personally, I'm done being falsely shamed into silence.

On May 1, the U.S. House passed overwhelmingly H.R. 6090 to create a federal **antisemitism law**. It employed the same working source for defining antisemitism as South Dakota did - that Alliance in Berlin. But this time conservative pundit Charlie Kirk shocked many and asked on X (formerly Twitter), "did the US House just pass an antisemitism bill effectively proclaiming some of the Bible illegal?" Tucker Carlson replied to him on X, "Yes, the New Testament." People went nuts and the last I knew the bill has stopped, for now. Candice Owens, Stew Peters and many other podcasters and many black artists are waking up to the grave danger of Talmudism and their long-standing "**antisemitic**" screed they've used to neutralize their critics.

If you think this is extreme and your free speech rights in South Dakota won't require you to suppress portions of the NT, then inquire into the decades-long effort of the American Jewish Congress to get the Vatican to renounce such texts from the New Testament.

Hopefully this shocks many of the evangelical dispensationalists of South Dakota to realize whom they have been joined at the hip with, for decades. 150 years ago men by the name of Darby and Scofield introduced an heretical new view of New Testament Israel. I would argue that all the Mennonites, Methodists, Roman Catholics, Dutch Reformed, Lutherans, and others who settled South Dakota all believed that Christ and His body, the Church is New Testament Israel. Most of those pioneers also believed in the very real presence of Christ's Kingdom, here and now. Both Christ and John the Baptist proclaimed the kingdom was near at hand (Matt. 3:2, 4:17). Christ said it will be present with power to some who were listening to him before they die. (Mark 9:1) Jesus gave specific instructions on how to enter the Kingdom (Joh 3:3,5, Mt 5:20, 7:21). In Mat 5:11 Jesus proclaims the kingdom belonged to those "which are persecuted for righteousness sake." And the kingdom was manifested in casting out demons. Mt 12:28-30 Christ spoke of His kingdom as an actuality He was establishing, not a future potentiality.

Yet, Central Baptist Church of Sioux Falls says on their statement of faith, "We believe in the personal and visible return of the Lord Jesus Christ to earth and **the establishment of His kingdom.**" <https://centralsf.org/about-us/documents-and-policies/>

And that is a fundamental tenant of the dispensationalists who today love Talmudic Israel. The kingdom still to come will be headquartered in Israel, most of them believe. The late Jerry Falwell, Bob Jones, James Dobson, Paula White, John Hagee, Mike Huckabee, Pat Robertson, the late Billy Graham, and millions more all share this modern heresy of Israel and Christ's Kingdom. The Christian airwaves helped them immensely. And institutions like Talbot Seminary, Bob Jones University, Liberty University, Dallas Seminary and California's Biola University were started by dispensationalists.

Your US Senator John Thune attends this same Central Baptist Church (11/18/15, Argus Leader). And he is a graduate of Biola. Apparently, that's why Senator Thune appeared in a photo-opt a couple of years ago with the newly arrived Talmudic Rabbi in Sioux Falls. Even when only 0.03% of South Dakota's population is Jewish this Rabbi quickly made contact with all of your senior political leaders who agreed to pose for pictures with him. And if you heard a month or so ago, Kentucky Congressman Tom Massie told Tucker Carlson that the Talmudic political organization AIPAC has an assigned lobbyist for each member of the U.S. Congress. One wonders, who is John Thune's boy from AIPAC?

R. B. Kuiper for my Reformed friends, was President of Calvin Theological Seminary, when he wrote in 1936 that two grievous errors were "prevalent among American fundamentalists, Arminianism and the Dispensationalism of the Scofield Bible." "<https://americanvision.org/24834/who-is-defending-classic-dispensationalism-today/>

Scofield's Bible was launched into the three state Siouxland region, via Northwestern College, St. Paul, MN, and their radio network. Northwestern was founded in 1902 by Minneapolis Baptist Pastor, William Bell Riley. Riley was a devoted dispensationalist who shared the podium in 1914 at Moody Bible College with C.I. Scofield himself, where they along with a few others, spent a week teaching thousands of leaders how to popularize dispensationalism into American Christianity.

In 1947 Riley chose Billy Graham to succeed him as President of the college and Graham's major contribution was to open the first radio station KTIS in the Twin Cities. Later Graham's major advisor was a Talmudic Jewish lawyer who told him to stay out of the fight to end abortion. And Graham was one of the first to publicly approve the use of contraception within Christian marriage.

Northwestern College's radio network today includes KNWC (also known as Life 96.5) in Sioux Falls and much of dispensationalism's "grievous errors" and their pop music have poured in to the three-state region over their air waves for decades.

Talmudists today control -- or they've fooled many gentiles to assist in controlling - propaganda, central banking, global banking (of which I have no doubt many have their Trusts here in South Dakota), big pharma, medicine, much of evangelicalism, the State Department, most of the top law schools, porn, Hollywood in general, therapy/counseling, etc. The sexual revolutionaries at every level of culture, propaganda, education and government were mostly Talmudists.

Long term, I have every confidence in the power of the Gospel. God's will, will be done on earth as it is in heaven. (Which BTW, dispensationalists rarely pray the Lord's Prayer because of that petition, "Thy will be done on earth as it is in heaven) But victories come on the heels of our own repentance/ humility, our faith in Christ, and obedience to His Law. When God's people do such, God will work in men's hearts and creation itself to see His name glorified.

Vote No on Amendment G and do America a favor and ask your state legislators and your Governor to repeal their Free Speech attack against Christianity. I believe in Romans 11 and do pray for the conversion of the Talmudists to Jesus Christ.
